 - 3. As per Advertisement No. 01/2024, the examination scheme for post code-802/24 is IV- Tier Examination. Tier-I (MCQ) examination conducted by the DSSSB on 03.03.2024, 10.03.2024, 16.03.2024, 17.03.2024, 18.03.2024, 30.03.2024 & 31.03.2024.
 - 4. Accordingly, based on the performance in the Tier-I examination, 15,231 candidates in the merit have been provisionally shortlisted for appearing in Tier-II Descriptive Test (English Language) subject to attaining minimum qualifying marks and correctness of the information furnished by the candidate in their online application forms. The shortlisted candidates shall be informed separately for Tier-II written examination.

Since documents have not been called from the candidates along-with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of name in the list of candidates qualifying for appearing in Tier-II examination does not entitled them any right over the post.

Reserved category candidates who have obtained marks above or equal to last shortlisted UR candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, otherwise for selection in their respective category, subject to availability of vacancies.
