- The DSSSB vide its advertisement No. 03/23 read with Corrigendum No. 5607-19 dated 08.07.2024 and Addendum Nos. 5204-16 & 5675-87 dated 04.03.2024 & 27.05.2024 respectively, had advertised Total 293 vacancies including ExSM- 27 & SP-14 (UR- 171, EWS- 45, OBC-28, SC- 21 & ST- 28) for the post of WARDER (RESERVED FOR MALE ONLY) under Post Code- 113/23 in DELHI PRISONS.
- 2. The examination (online mode) was conducted in different shifts of 10.06.2024, 11.06.2024, 12.06.2024, 13.06.2024, 14.06.2024, 15.06.2024, 16.06.2024, 18.06.2024, 19.06.2024, 20.06.2024 & 22.06.2024.
- 3. The normalized marks obtained by **62102 candidates** who have duly appeared in examination held on different dates as mentioned above have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dsssbonline.nic.in**
- 4. Based on the performance in the Tier-I examination (online Mode), a total of 3343 candidates (including bracketed candidates) who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Physical Endurance Test (PET), subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Physical Endurance Test (PET) separately.

- 5. Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Physical Endurance Test (PET) does not entitle them any right over the post.
- 6. Reserved category candidates who have obtained marks above or equal to the last shortlisted candidates, have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category,

- subject to availability of vacancies, otherwise for selection in their respective category.
- 7. As per the Board Policy the minimum qualifying marks in one Tier written examination for UR & EWS Category Candidate is 40%, for OBC candidate is 35%, for SC, ST & PH candidate is 30% and for ExSM 5% relaxation of marks in their respective applied category (subject to a minimum of 30%).
- 8. The details of Physical Endurance Test (PET) shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.
- 9. The above short-listing for Physical Endurance Test (PET) for the post of Warder (Reserved for Male only) under Post Code- 113/23 in Delhi Prisons will be subject to outcome of pending court cases, if any.
- 10. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
